Course Description:

Public scrutiny of law enforcement operations is currently at unprecedented levels. This creates additional challenges for government auditors working to evaluate risks and conduct audit engagements related to law enforcement operations. Law enforcement audits differ from other governmental audits and can be hugely successful when performed in consideration of risks, procedures, and the culture unique to the law enforcement environment. Erin Kenney, CIA

Erin retired as the Departmental Audit Manager for the Los Angeles Fire and Police Pension Fund with over \$18 billion in assets. Prior to joining the Fund in 2010, Erin was the Acting Commanding Officer of the Los Angeles Police Department's award-winning Audit Division and was responsible for leading the unit beyond a federal Consent Decree and to international recognition for best practices in police auditing and training.

Erin is a recipient of the American Society for Public Administration's Henry Reining Award; a past President of the International Law Enforcement Auditors Association; an active member of the Institute of Internal Auditors, the Association of Public Pension Fund Auditors, the Association of Certified Fraud Examiners; and serves on the Association of Local Government Auditors' Peer Review Committee.

A certified instructor for the California Peace Officer Standards and Training Robert Presley Institute of Criminal Investigation, she has developed and continues to conduct police auditing training to both sworn law enforcement and civilian audit professionals. Erin obtained a Bachelor's degree in political science from USC.

Penny Bartley

Penny Bartley retired as the Executive Director of South Correctional Entity (SCORE Jail), in Des Moines, Washington. Penny created the initial proposal for SCORE, which was established in 2009, and is the only regional jail facility that is an independent government agency in the State of Washington. It provides jail services for seven member cities and numerous contract agencies in the metropolitan Seattle area. SCORE has a capacity of 802 inmates and handles more than 24,000 bookings per year. While she was Executive Director, SCORE became the first jail in Washington to receive accreditation through the Washington Association of Sheriffs and Police Chiefs (WASPC) and the National Commission on Correctional Healthcare (NCCHC) and successfully completed an audit for compliance with PREA standards.

Prior to the creation of SCORE, Penny worked for the Renton, Washington, Police Department where she ran the divisions responsible for jail operations, and the records and evidence functions for 15 years. She was also the Public Information Officer for the Department. Her early career including working for police departments in Lynnwood and Normandy Park, Washington.

Penny has a master's degree in Justice Administration from University of Alaska Fairbanks and a Bachelor's Degree in Law and Justice from Central Washington University. She is a Certified Jail Manager (American Jail Association) and a Certified Corrections Executive (American Correctional Association). Penny has been a presenter and instructor at local, state, and national conferences on a variety of correctional topics including facility construction, operations, liability, and working with advocacy organizations in jail settings.
